## TERMS AND CONDITIONS

### GENERAL

- Tee times are available to Members up to 14 days in advance. Wildstone reserves the right to modify booking procedures as necessary to maximize and accommodate both Member and green fee play. Access to the golf course is subject to availability.
- **Weekday Membership** play is valid Monday-Thursday, including Stat Holiday Mondays. Weekday players are eligible for the Twilight Rate of \$55.00 anytime on Friday, Saturday or Sundays. They are eligible to play in Sunday Skins 2:00-5:00 PM, provided they buy into \$25.00 Sunday Skins/meal pack.
- **Junior, Student and PS play** is restricted before 12:00 Noon on Fridays, Saturdays and Sundays.
- Juniors are not eligible for purchase of power cart pass. Adult Members may purchase power cart passenger seat for their child for use when riding with the adult. When juniors are playing without adults, they are only permitted to walk. Power carts must be operated by patrons with a valid drivers license, and signed for by patrons aged 19 or older.
- Wildstone may address the cancellation of Membership under specific circumstances.
- Wildstone Management reserves the right to modify Membership terms and conditions as needed.

### REFUSAL OF PRIVILEGE

- Wildstone Golf Course reserves the right to suspend course privileges to anyone deemed to be in violation of terms and conditions or violation of respect of the property and the game of golf.
- Wildstone reserves the right to cancel any Membership and prorate a refund.

### NO SHOW & CANCELLATION POLICY

- All Members must provide 24 hours notice to the Pro Shop if they cannot make their scheduled tee time. If a scheduled tee time is not attended or cancelled within 24 hours, Wildstone will document a "strike" to the Member. Repeated strikes will be subject to action taken by Wildstone Management. Wildstone reserves the right to restrict the booking privileges or suspend Members who repeatedly abuse booking privileges.
- When reserving tee times, Members are responsible for the number of players booked.
- Notify the Pro Shop of any booking changes prior to arrival and check-in so vacancies can be filled.
- Wildstone reserves the right to pair singles, twosomes and threesomes. (see single player policy)

### CHARGING PRIVILEGES

- Members are entitled to charging privileges for Golf, Food and Beverage, Merchandise and services provided by Wildstone Golf Course.
- Account statements will be sent out at months end and the balance will be charged to your provided credit card on the 15<sup>th</sup> of the following month.
- Lack of payment on account will result in loss of golf privileges until account is paid in full.
